# Why Become a Certified Provider?

## Potential Providers Information

You can operate your own home-based business, be with your children and care for others with Goodfellow Family Child Care. The FCC staff will train and help you provide responsible and safe, in-home care for children 2 weeks to 12 years (including your own children) in your government home or affiliated off-base home.

The FCC program is looking for individuals who wish to be child care professionals.

- You must be over 18 years of age
- Able to read and speak English
- Be in good mental and physical health
- Be willing to undergo a comprehensive background check

You can set your own hours and care for children on a hourly, part-day, full-day or extended basis.

**Care for the children of our military and civilian personnel while establishing a professional career for yourself.**

Any Families residing in base housing who provide care for other families children on a regular basis or more than 10 ours per week must be licensed by Goodfellow Air Force Base Childcare program.



## How to Become a Certified Provider

On Base Home Requirements  
(Homes located on Goodfellow AFB)

1. Contact the FCC Coordinator
2. Attend an FCC Orientation or pick up a FCC Home Care Packet (packets can be picked up at the Child Development Center)
3. Complete Background & Fingerprint checks (note: ALL household members over 12 years old must complete) -- Min 4-6 weeks to complete
4. Attend 24 Hrs Training with FCC Trainer (Includes CPR, First-aid, Child Abuse & more)
5. Provide proof of "Home Liability Insurance" of \$500,000
6. Provide "Contract for Care"
7. Complete various mandatory Home Inspections to include: FIRE, SAFETY, HEALTH, and FCC inspection

### Homes OFF BASE or in THE LANDINGS:

1. Must first be certified by the State of Texas: For State Certification Information call 432-368-2693.
2. Then meet all "ON BASE" Home Requirements (see above)



## Expanded Child Care (ECC)

The ECC Program assists families in obtaining high quality child care from certified providers at or near the installation.

Child Care is available for children 2 weeks to 12 years. Use of ECC is permitted once all paperwork is completed and approved.

Parents using ECC are expected to arrange their workschedule to have ample time to be with their children. ECC may not be used to support school attendance, off-duty employment, or any other child care needs not authorized. Care is dependent on the availability of funding and providers.
